NOTICE

This is to notify that the dates for taking fresh applications and admissions in Assam Higher Education Admission Portal is extended till 28<sup>th</sup> September, 2023 and 29<sup>th</sup> September 2023 respectively and for update by previously registered candidates, for Spot admissions.

Instructions for Institutions and applicants

1. All admissions will be subject to department wise vacancies published for every Institution in the Admission portal only against the seats lying vacant or due to vacancy caused as a result of applicant taking admission in other Institution.
2. Applicants who are not yet admitted to any Institution will get first preference during the final round of admissions. This round of admissions is to fill up vacancies in Colleges/Universities due to two reasons: either the seats were not filled during the entire admission process or due to admitted students being selected for admissions in other Institutions for same or different programme through any of the entrance based mode of admissions like CUET or CLAT or NEET or JEE etc.
3. All applicants who got selected and admitted in other Institutions need to compulsorily intimate the Colleges/Universities about the cancellation of their admission through formal communication to the respective official e-mail IDs of the Institution where they were earlier admitted. Thereafter, the concerned Institution will mark the admission as cancelled and the cancellation will automatically reflect in the vacancy of that particular programme in the College.
4. This admission round is not for students who are already admitted through Non-CUET admission process in similar programmes in Colleges/Universities of Assam. However, based on request of the students, if Institutions where students are admitted and Institution where they are offered a seat mutually decide to admit the applicant in the new institution upon cancellation of the previous admission, this may be done mutually and amicably. But, it will be the discretion of the Institution whether or not to allow such cancellation of the admitted student.
5. Applicants should not just register but also complete their profiles and submit applications on Assam Higher Education Admission Portal to be eligible for final round of admissions.
6. Students who had not registered previously can register afresh and those who have already registered can continue with their previous registrations.
7. Students can provide upto 10 preferences of Programmes either in the same College or multiple Colleges. They are advised to give maximum number of preferences in the application form.
8. Those who have submitted upto 10 preferences previously can also edit/update their preferences before 28<sup>th</sup> September, 2023.
9. After the final round of Spot admissions are over, admitted students will not get a chance to cancel their admissions thereafter.
10. All updation related to Fee Waiver scheme in the portal is to be completed within 30<sup>th</sup> September, 2023.
11. If any discrepancy is found in admitting students or cases like document was verified but admission was not granted, such matters are to be sorted in the portal latest by 30<sup>th</sup> September, 2023.
12. No admission related query will be entertained after 30<sup>th</sup> September, 2023. So, the Institutions and applicants are to take strict cognizance of the matter.

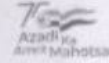
