- 2. 12 Marks will be evaluated internally by the concerned department/respective Teacher.
- 08 Marks will be evaluated by an External Examiner along with an Internal Examiner of the concerned department based on the Viva voce considering the following:
  - Clarity on the topic, knowledge & understanding (05 marks)
  - Project presentation & Communication skill (03 marks)
- 4. The Head of the Department or the concerned subject teacher will make necessary arrangement for availability of the Project report duly certified by the guide to the concerned External Examiner on the day of the viva voce.
- 5. The Pass mark in the Project work is 08 out of 20 and Pass mark for theory is 24 out of 80.
- 6. Each student will have to pass individually in both Theory & Project work.
- 7. The Head of the concerned institution shall appoint an External Examiner in consultation with the Department of the concerned subjects.
- 8. The External Examiner should be senior faculty of Govt./Provincialised Higher Secondary Schools/Colleges/Universities and shall be appointed by the Head of the Department/Institution
